Dear Mr. Kaul,

I am reaching out to you regarding Rosalio Gutierrez Jr.

Mr. Gutierrez was born on April 10th, 1980 and was a father of two residing in Kenosha WI. On May 17th, 2020, Mr. Gutierrez went missing. Despite being close with his mother and his children, he has not been heard from since that date. Although there was an investigation of sorts conducted by local authorities, the whereabouts of Mr. Gutierrez remains a mystery.

As a concerned citizen and member of the general public, I believe it is my duty to bring to your attention the lack of investigation into the disappearance of Mr. Gutierrez. I am contacting you now for your assistance as all concerns expressed to the local authorities have resulted in no further action or assistance.

One concern is that certain leads suggested Mr. Gutierrez's remains might be located at the Pheasant Run Security Landfill (Address: 19419 60th St., Bristol WI), but that site was never examined. That site, as well as several others, were identified as possible locations of interest, but only locations detectives believed to be connected to Zachariah Anderson were searched. Although nothing of evidentiary value was found in any location connected to Zachariah, no further searches were completed.

I believe an immediate focus on Mr. Anderson placed blinders on local authorities, precluding them from pursuing several legitimate leads. Zachariah Anderson was immediately accused and Kenosha Police Department spent seven months of unproductive time ignoring other possibilities while they waited for forensic results. Zachariah would eventually be charged and convicted of the murder of Mr. Gutierrez, despite an inconclusive investigation with only one pinhead-sized speck of Mr. Gutierrez's DNA to account for his whereabouts.

I am quite concerned that with Mr. Anderson's conviction, local authorities have all but given up on the search for Mr. Gutierrez. This is a travesty, and the insufficient effort put towards discovering the truth of his disappearance is entirely unfair to Mr. Gutierrez's mother and children. It is prudent that Mr. Gutierrez is located, so that his family may understand the full and true circumstances of his disappearance; they deserve to put him to rest and properly grieve his loss.

It is my sincere hope that your office will initiate an investigation into this matter.
